We envision a world where sustainable development of energy and mineral resources is achieved through effective and efficient governance.

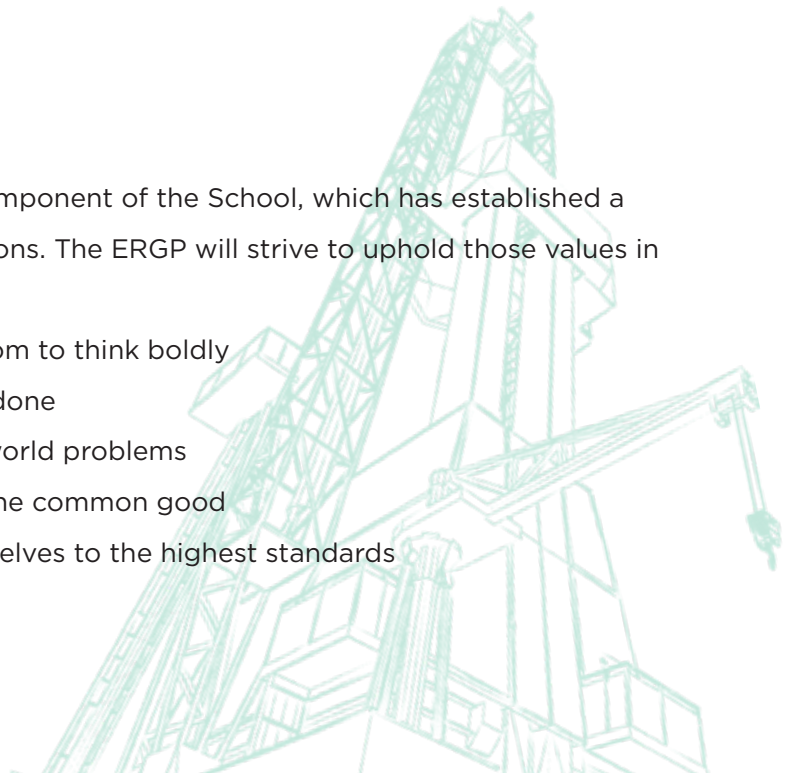
MISSION

there is increasing demand for data-driven research that quantifies the benefits of accountability and transparency with respect to environmental, social and governance (ESG) factors.

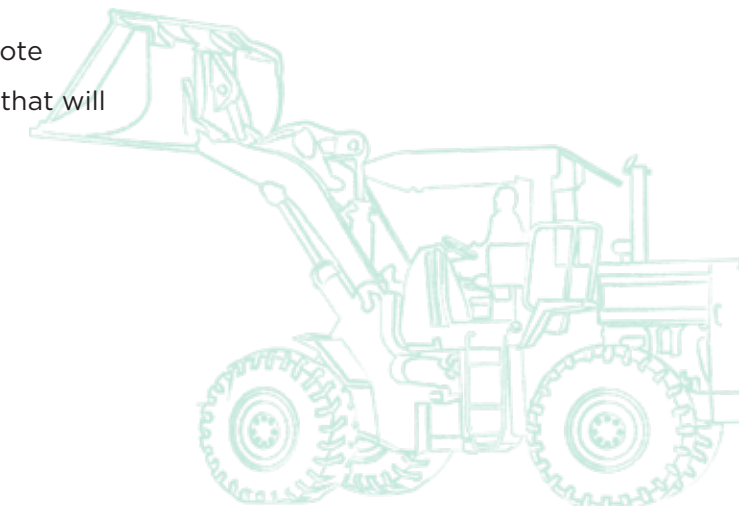


Promote Excellence in Domestic and International Teamwork and Service Delivery through Relationships with Communities and Partners -

THE GLOBAL CONTEXT

Many developing nations have very limited experience with mineral and energy resource development. Ensuring environmentally responsible and sustainable resource development that attracts investment requires advice and assistance with:

- Understanding the geological fundamentals, exploration and production processes and cycles, and the underlying economics of mineral and energy development
- Developing a policy framework that balances attracting investment with economic benefit to the state and local communities
- Implementing a sound legislative framework that incorporates fairness, transparency and accountability
- Implementing a sound regulatory framework, including an institutional foundation and organization fit for the nation's governance structure, regulatory requirements, compliance and assurance with regulatory requirements, and transparent reporting

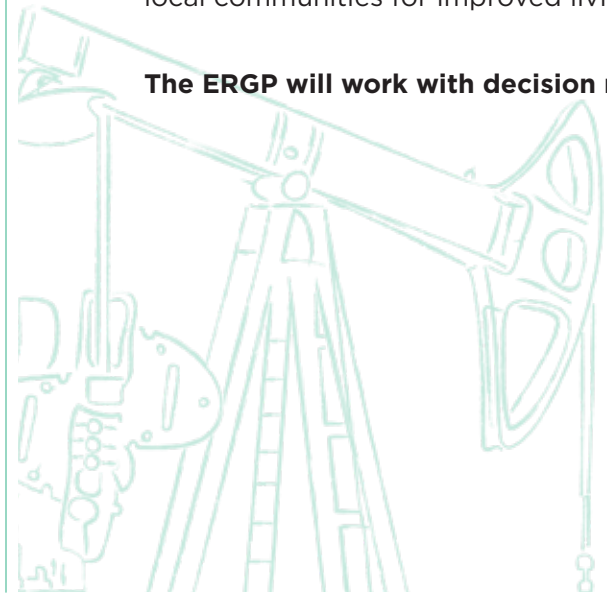
